On behalf of the OPSI Board and other commissioners and staff, I thank you for your participation in our Spring Strategy Meeting in Columbus, Ohio. Please convey our thanks to your executives – Mike Kormos, Andy Ott, Stu Bresler, Steve Herling, Denise Foster, and Paul Sotkiewicz – for their participation as well. Your team's presentations were very informative and I hope we have more of such presentations in the future.

As you know, the OPSI Board held its monthly meeting in Columbus on Friday, April 8. One of the items we discussed was the idea you and your team raised regarding a meeting to examine how public policy issues could be dealt within the context of PJM regional planning process. There was much discussion on how OPSI could help move this forward and the OPSI Board approved that:

PJM hold a meeting among PJM, OPSI, and other state policymakers to discuss how PJM may consider adjusting its transmission planning process to accommodate state policies with the understanding that decisions made at that meeting will not be binding on OPSI or its individual Member Regulatory Agencies.
